Please read the Rules carefully before participating. You must follow the directions provided within these Rules to be eligible to receive the Prizes.

**ELIGIBILITY:** This Sweepstakes is open only to legal residents of Michigan who are eighteen (18) years of age or older at the time of entry. Notwithstanding the prior sentence, the promotion Sweepstakes is void where prohibited or restricted by law, rule or regulation. Enter online at <https://www.artvan.com/rules>. Entrants must be at least eighteen (18) years old to participate in the Sweepstakes and a legal resident of Michigan. By entering the Sweepstakes, eligible individuals will be entered into the Promotion, with a chance to win the random drawing for the Prize as described in these Rules ("**Entrants**"). Each Winner will receive: two (2) tickets to attend the March 6, 2020, Detroit Red Wings' game OR the March 10, 2020, game held at Little Caesars Arena, 2645 Woodward Ave., Detroit MI, 48201. The seat locations shall be determined in Art Van's sole discretion. Winner is responsible for his/her own transportation and parking. Art Van requests that the Winner and his/her guest dress in Detroit Red Wings branded clothing and must refrain from displaying the logos of any other NHL team.
